## RESOLUTION 54-16

**A RESOLUTION BY THE FOLLY BEACH CITY COUNCIL AUTHORIZING ADMINISTRATION TO REIMBURSE \$229 TO THE FOLLY BEACH EXCHANGE CLUB FOR A PERMIT APPLICATION FEE FROM THE BUILDING PERMIT REVENUE ACCOUNT AND WAIVE PERMITTING FEES THROUGH DECEMBER 31, 2016.**

WHEREAS, The Folly Beach Exchange Club exists to serve the citizens of Folly Beach; and

WHEREAS, The building sustained damage during Hurricane Matthew that must be repaired.

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of Folly Beach, South Carolina, that \$229 from the Building Permit Revenue account shall hereby be reimbursed to the Folly Beach Exchange Club and future building permit fees shall be waived through December 31, 2016.
