



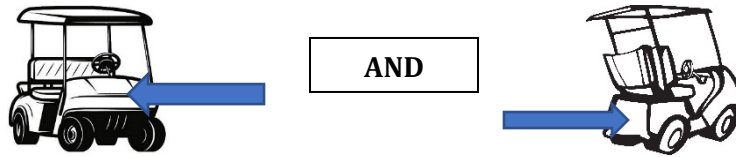

RESIDENTIAL GOLF CART PERMIT APPLICATION

1. The Fees for golf cart permits are \$5.00 annually for full time residents, \$10.00 for part time. There is no charge for any person 65 years of age or older. City Permits expire on December 31st of each year.
2. To obtain a decal, you must present a valid driver's license, golf cart insurance card, and proof of State golf cart registration. Decals will only be issued for golf carts registered on Folly Beach (S.C. Code 56-2-105). **This is not a Parking Decal.**
3. You must read and sign the attached rules sheet.
4. A lost, or stolen decal may be replaced upon payment of a fee of \$10 and the execution of a sworn statement that the decal was lost or stolen. No decal shall be replaced more than once in any calendar year.
5. Decals are to be displayed so as to be visible from the front and rear on the driver's side (see below)

LAWS FOR GOLF CARTS IN FOLLY BEACH

(A) Golf carts may cross but may not be driven on Center Street or Folly Road.

(B) The driver must be at least 16 years old (18 years old for rental golf carts) and must be in possession of a valid driver's license, the registration certificate issued by the South Carolina Department of Motor Vehicles (SCDMV), and proof of liability insurance for the golf cart.

(C) Golf carts shall comply with all traffic rules and regulations and parking laws.

(D) A golf cart may only be driven within four miles of the address on the SCDMV registration.

(E) A golf cart may only be driven during daylight hours and may not be driven any time when windshield wipers on automobiles are in use or when other factors make it difficult to see persons or vehicles at a distance of five hundred feet ahead.

(F) The number of occupants in a golf cart shall be limited to the number of persons for whom individual seating is installed and provided on the golf cart. The operator and all occupants shall be seated in the golf cart and no part of the body of the operator or any occupant shall extend outside the perimeter of the golf cart while the golf cart is in motion.

(G) The driver of a golf cart shall use hand signals when turning or stopping unless the golf cart is equipped with turn signals.

(H) Golf carts shall not be operated on private property without permission.

(I) A golf cart, whether owned or rented, must have current decals from the SCDMV and the City of Folly Beach that are clearly visible on the front and rear of the golf cart on the driver's side. **This is not a Parking Decal.**

CERTIFICATION BY OWNER

I have read the rules about the operation of golf carts in Folly Beach. I will not allow anyone to operate the golf cart who is not qualified to operate a golf cart or who has not read the rules about the operation of golf carts in Folly Beach.

I certify that that my golf cart has a rear-view mirror and is in safe operating condition.
